### INTENDED USE

For In Vitro Diagnostic Use.

For professional users.

Diagnosis should be made based on the clinical history and results of diagnostic tests of the patient.

### **FORM**

Liquid. Ready to use.

immunohistochemical staining. AEC may produce red precipitates at the site of the target antigen or nucleic acid reacting with peroxidase.

### **USAGE**

Adjust **N**-Histofine<sup>®</sup> Simple Stain AEC Solution to room temperature prior to use.

React the objective tissue section with peroxidase conjugate in advance.

At the same time, staining of Negative control slide using PBS in place of primary antibody is recommended to be prepared for checking the staining result.

For color development, incubate the tissue section on the slide with 1-2 drops of **N**-Histofine Simple Stain AEC Solution using Dropping bottle at room temperature for 5-20 minutes.

Adjust the reaction time by microscopic observation by contrast with the Negative control slide.

After adequate coloration, wash the slide with tap water.

This red deposit is soluble in organic solvent. Therefore, after counterstain, the slide can be mounted with water-soluble mounting media.

### **STORAGE**

Store at 2-8°C.
